RE: "Joint Powers Authorities: Issues of Viability, Control, Transparency, and Solvency"

#### Dear Judge Sanders:

This letter constitutes, in accordance with Section 933.05 of the California Penal Code, the response of the Huntington Beach Public Financing Authority (HBPFA) to the Orange County Grand Jury 2014-15 Report, dated June 29, 2015, titled "Joint Powers Authorities: Issues of Viability, Control, Transparency, and Solvency" (Grand Jury Report). The enumerated items in this response correspond to the Findings and Recommendations contained in the Grand Jury Report.

#### Grand Jury Findings and Recommendations

The HBPFA is providing the following response to each of the findings and recommendations, in accordance with California Penal Code Sections 933 and 933.05 (a) and (b).

#### **Findings**

**F.3** Orange County has 18 vertical Joint Powers Authorities created by a city along with its redevelopment agency that no longer exists. The Grand Jury determined that these Joint Powers Authorities serve no benefit to the public or the taxpayers and have the potential for misuse or obfuscation of public funds.

Response: Disagree with Finding. Effective July 17, 2014, the Huntington Beach Public Financing Authority Joint Powers Agreement was amended to remove the Huntington Beach Redevelopment Agency as a member (see Attachment #1). An Amendment of a Joint Powers Agreement form was filed with the State of California Secretary of State on July 25, 2014 (see Attachment #2).

**F.4:** Vertical Joint Powers Authorities with a single controlling entity, such as a city council, have the potential to use this organizational structure as a shell company to avoid other legal constraints on the controlling entity and to obfuscate taxpayer visibility.

**Response:** Disagree with finding. The City's Joint Powers Authorities are created pursuant to Articles 1, 2, and 4 of Chapter 5 of Division 7 of Title 1 of the California Government Code, commencing with Section 6500 (the Joint Exercise of Powers Act), which provides statutory authority for the creation of JPAs. In order to ensure transparency to taxpayers, JPAs must follow the Public Records Act, the Political Reform Act, and the Ralph M. Brown Act.

**F.5:** Vertical Joint Powers Authorities in which the controlling entity transfers assets from itself to a Joint Powers Authority for the purpose of obtaining additional funding, or signs a long-term lease to a Joint Powers Authority to obtain assets, are avoiding transparency and are not acting in the best financial interest of the taxpayers.

Response: Disagree with finding. As noted in the City's response to Finding F.4, The City's Joint Powers Authorities are created pursuant to Articles 1, 2, and 4 of Chapter 5 of Division 7 of Title 1 of the California Government Code, commencing with Section 6500 (the Joint Exercise of Powers Act), which provides statutory authority for the creation of JPAs. Statutory authority for JPAs to issue revenue bonds is included in Article 4 of Chapter 5 of Division 7 of Title 1 of the California Government Code, commencing with Section 6584 (the Marks-Roos Local Bond Pooling Act of 1985). In order to ensure transparency to taxpayers, JPAs must follow the Public Records Act, the Political Reform Act, and the Ralph M. Brown Act. Transparency is further ensured through the regular reporting and data collection of JPAs by several state agencies, including the Secretary of State's Office, the State Controller's Office, and the California Debt and Investment Commission.

Additionally, the power of Joint Powers Authorities to issue revenue bonds has been further affirmed by the ruling of the Supreme Court in Rider v. City of San Diego, (198) 18 Cal. 4<sup>th</sup> 1035, 1051, which noted that the power of a JPA to issue revenue bonds "does not derive from any power of the contracting parties to issue bonds," but rather from state law.

#### Recommendations

**R.2** All Vertical Joint Powers Authorities created by a city along with its redevelopment agency should submit the necessary paperwork with the State of California requesting termination of their existence. (F.3)

**Response: Completed.** Effective July 17, 2014, the Huntington Beach Public Financing Authority Joint Powers Agreement was amended to remove the Huntington Beach Redevelopment Agency as a member (see Attachment #1). An Amendment of a Joint Powers Agreement form was filed with the State of California Secretary of State on July 25, 2014 (see Attachment #2).

**R.3:** All Joint Powers Authorities should take the following actions to insure transparency to the taxpayers: (1) have an annual outside audit, (2) post the complete audit on their city website as a separate Joint Powers Authority entity, (3) send the audit to the County Controller and the State Auditor, and (4) ensure the required reports are filed annually to the County and the State. (F.4, F.5).

**Response:** Completed. In accordance with California Government Code Section 6505(b) and (c), the Huntington Beach Public Financing Authority is audited on an annual basis by a certified public accounting firm. The audit of the HBPFA is completed in conjunction with the City's annual financial statement audit and is incorporated in the City's Comprehensive Annual Financial Report (CAFR).

Additionally, the audited financial statements incorporating the financial reports of the Huntington Beach Public Financing Authority are filed with the California State Controller's Office on an annual basis in conjunction with submittal of the City's annual Single Audit Report.

In accordance with the above recommendation, the CAFR will also be submitted to the County Controller's office on an annual basis. The FY 2013-14 CAFR was submitted to the County Controller on August 11, 2015 (see Attachment 3).

The City of Huntington Beach Successor Agency (Agency) notified the California Department of Finance (Finance) of its June 17, 2014 Oversight Board (OB) resolution on June 17, 2014. Pursuant to Health and Safety Code (HSC) section 34179 (h), Finance has completed its review of the OB action.

Based on our review and application of the law, OB Resolution No. 2014-03, authorizing the Agency to execute and deliver a second amendment to the Joint Exercise of Powers Agreement relating to the Huntington Beach Public Financing Authority (Financing Authority) is approved.

## SECOND AMENDMENT TO JOINT EXERCISE OF POWERS AGREEMENT

THIS SECOND AMENDMENT TO JOINT EXERCISE OF, POWERS AGREEMENT (this "Second Amendment") is made and entered into as of july17, 2014, by and among the CITY OF HUNTINGTON BEACH (the "City"), the SUCCESSOR AGENCY TO THE REDEVELOPMENT AGENCY OF THE CITY OF HUNTINGTON BEACH (the "Agency"), and the HUNTINGTON BEACH HOUSING AUTHORITY (the "Housing Authority").

#### WITNESSETH:

WHEREAS, pursuant to the Community Redevelopment Law (Part 1 of Division 24 of the Health and Safety Code of the State of California and referred to herein as the "Law"), the City Council of the City created the former Redevelopment Agency of the City of Huntington Beach (the "Former RDA"); and

WHEREAS, the Former RDA was a redevelopment agency, a public body, corporate and politic duly created, established and authorized to transact business and exercise its powers, all under and pursuant to the Law; and

WHEREAS, the City agreed to serve as the successor agency (referred to herein as the Agency) to the Former RDA commencing upon the dissolution of the Former RDA on February 1, 2012 pursuant to Assembly Bill Xl 26 ("AB 26"); and

WHEREAS, pursuant to Articles 1, 2 and 4 of Chapter 5 of Division 7 of Title 1 of the California Government Code, commencing with Section 6500 thereof (the "Act"), two or more public agencies may by agreement jointly exercise any power common to the contracting parties; and

WHEREAS, pursuant to the Act and the Joint Exercise of Powers Agreement, dated as of March 7, 1988, as amended by the First Amendment to Joint Exercise of Powers Agreement, dated as of May 16, 1988 (collectively, the "First Amended Joint Powers Agreement"), each by and between the City and the Former RDA (collectively, the "Original Members"), the Original Members created and established the Huntington Beach Public Financing Authority (the "Authority") for the purposes set forth in the First Amended Joint Powers Agreement and to exercise the powers described in the First Amended Joint Powers Agreement, which each of the Original Members determined would provide significant public benefits; and

WHEREAS, the City, the Agency and the Housing Authority now desire to enter into this Second Amendment in order to substitute the Housing Authority for the Agency as a member of the Authority (each, a "Member" and collectively, the "Members") and to make certain other amendments to the First Amended Joint Powers Agreement;

**NOW**, **THEREFORE**, for and in consideration of the mutual promises and covenants contained herein, the parties hereto agree as follows:

Section 1.1. Substituted Member. The First Amended Joint Powers Agreement is hereby amended to substitute the Housing Authority for the Agency as a Member of the Authority such that the term "Agency" is replaced with the term "Housing Authority" every place it appears in the First Amended Joint Powers Agreement. The Housing Authority is hereby afforded the rights, benefits and protections of the Agency (as such term is used in the First Amended Joint Powers Agreement) provided for under the First Amended Joint Powers Agreement as amended by this Second Amendment and hereby undertakes the obligations of the Agency (as such term is used in the First Amended Joint Powers Agreement) under the First Amended Joint Powers Agreement as amended by this Second Amendment. (In no manner does the Housing Authority assume any other obligation of the Agency under any other agreement, bond, note, resolution, ordinance, agreement or other instrument to which the Agency is a party or is otherwise subject.) The Agency is hereby relieved of the obligations of the Agency (as such term is used in the First Amended Joint Powers Agreement) provided for under the First Amended Joint Powers Agreement as amended by this Second Amendment.

Section 1.2. Amendment to Section 8.01. Section 8 of the First Amended Joint Powers Agreement, entitled "Notices", is hereby amended to read in full as follows:

Section 8.01. Notices. Notices hereunder shall be in writing and shall be sufficient if delivered to:

City of Huntington Beach 2000 Main Street Huntington Beach, California 92648 Attention: City Manager

Huntington Beach Housing Authority 2000 Main Street Huntington Beach, California 92648 Attention: Executive Director

Section 1.3. Effect of Second Amendment. This Second Amendment and all of the terms and provisions herein contained shall form part of the First Amended Joint Powers Agreement as fully and with the same effect as if all such terms and provisions are set forth in the First Amended Joint Powers Agreement from and after the effective date of this Second Amendment. The First Amended Joint Powers Agreement is hereby ratified and confirmed and shall continue in full force and effect in accordance with the terms and provisions thereof, as heretofore amended and supplemented, and as amended and supplemented hereby. If there shall be any conflict between the terms of this Second Amendment and the terms of the First Amended Joint Powers Agreement (as in effect on the day prior to the effective date of this Second Amendment), the terms of this Second Amendment shall prevail.

Within 30 days after the effective date of this Second Amendment, the Authority will cause a notice of this Second Amendment to be prepared and filed with the office of the Secretary of State of the State of California in the manner set forth in Section 6503.5 of the Act.

- Section 1.4. Counterparts. This Second Amendment may be executed in counterparts, each of which shall be deemed an original.
- Section 1.5. Effective Date. Upon the execution and delivery hereof by the parties hereto, this Second Amendment shall be effective as of the day and year first hereinabove written.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF HUNTINGTON BEACH APPROVING THE EXECUTION AND DELIVERY OF A SECOND AMENDMENT TO JOINT EXERCISE OF POWERS AGREEMENT AND OTHER MATTERS RELATED THERETO RELATING TO THE HUNTINGTON BEACH PUBLIC FINANCING AUTHORITY

WHEREAS, pursuant to the Community Redevelopment Law (Part 1 of Division 24 of the Health and Safety Code of the State of California and referred to herein as the "Law"), the City Council of the City of Huntington Beach (the "City") created the former Redevelopment Agency of the City of Huntington Beach (the "Former RDA"); and

WHEREAS, the Former RDA was a redevelopment agency, a public body, corporate and politic duly created, established and authorized to transact business and exercise its powers, all under and pursuant to the Law; and

WHEREAS, the City agreed to serve as the successor agency (referred to herein as the Agency) to the Former RDA commencing upon the dissolution of the Former RDA on February 1, 2012 pursuant to Assembly Bill Xl 26 ("AB 26"); and

WHEREAS, the City, the Successor Agency to the Redevelopment Agency of the City of Huntington Beach (the "Agency") and the Huntington Beach Housing Authority (the "Housing Authority") now desire to amend the First Amended Joint Powers Agreement pursuant to the Second Amendment to Joint Exercise of Powers Agreement (such Second Amendment to Joint Exercise of Powers Agreement, in the form presented to this meeting, with such changes, insertions and omissions as are made pursuant to this Resolution, being referred to herein as the "Second Amendment") in order to substitute the Housing Authority for the Agency as a member of the Authority and to make certain other amendments to the First Amended Joint Powers Agreement; and

WHEREAS, there has been prepared and submitted to this meeting a form of the Second Amendment; and

WHEREAS, the City Council desires to authorize the execution and delivery of such document and the performance of such acts by or on behalf of the City as may be necessary or desirable to effect the execution and delivery of such document;

## NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF HUNTINGTON BEACH, DOES HEREBY RESOLVE, DETERMINE AND ORDER AS FOLLOWS:

- Section 1. The Second Amendment, in substantially the form submitted to this meeting and made a part hereof as though set forth in full herein, be and the same is hereby approved. The City Manager, the Assistant City Manager and the Director of Finance of the City, and such other officers of the City as the City Manager may designate (collectively, the "Authorized Officers") are, and each of them is, hereby authorized and directed, for and in the name of the City, to execute and deliver the Second Amendment in the form presented to this meeting, with such changes, insertions and omissions as the Authorized Officer executing the same may require or approve, such requirement or approval to be conclusively evidenced by the execution of the Second Amendment by such Authorized Officer.
- Section 2. The officers and employees of the City are, and each of them is, hereby authorized and directed, for and in the name of the City, to do any and all things and to execute and deliver any and all documents which they or any of them deem necessary or advisable in order to consummate the transactions contemplated by this Resolution and otherwise to carry out, give effect to and comply with the terms and intent of this Resolution.
- **Section 3.** All actions heretofore taken by the officers and employees of the City in connection with or related to any of the agreements or documents referred to herein, are hereby approved, confirmed and ratified.

Section 4. This Resolution shall take effect immediately upon its adoption.
