
Dear Honorable Glenda Sanders:

On June 26, 2015, we received the 2014-2015 Orange County Grand Jury Report, "The Mental Health Revolving Door: A Problem for Police, Hospitals, and the Health Care Agency." In accordance with the requirements of the report, we are submitting this annual update to memorialize our progress related to the findings and recommendations.

Regarding Finding 1 (F1) - a minimum of 40 hours of training in Critical Intervention Training and Finding 2 (F2) - mandatory training specific to Laura's Law, our department has implemented training to address both concerns. Over the past year, we have sent department personnel to off-site training in addition to providing a 10 hour block of internal training. The internal training covered a variety of mental health topics, to include a specific section on Laura's Law. In total, our personnel have received 726 hours of mental health training since the report was published. Although we have not achieved 40 hours for all sworn personnel, we will continue toward that goal. As a tool to measure this training goal, we have created a matrix to track training department wide and identify personnel below the 40 hour minimum.

Attached to this report are spreadsheets that highlight the overall training hours of department personnel and training hours from April 2015 – April 2016.

In addition to providing additional training, we have also partnered with the Orange County Health Care Agency to create a PERT program. One day a week, a clinician is partnered with a police officer to address both acute and chronic mental health issues in the community. Thus far, the PERT program has been a great success and we hope to expand the program in the future.
