Dear Grand Jury:

Recommended in the Grand Jury's report of FY 2014-15 was a listing of all Orange County Joint Powers Authorities (JPA), and audited financial statements for each: recommendations R.3. through R.5.

In early September 2015 the Auditor-Controller's Internal Audit Division, researched and noted contact information for all the JPA's in the county. Upon compiling this comprehensive list each agency was sent a letter requesting their FY 2013-14 audited financial statements by September 18, 2015. We also informed them that going forward; they should send their audited financial statements to our office within 10 days of issuance. By late October, all of the JPA's had complied. Our office made electronic copies where necessary and posted all of the audited financial statements on our website on October 27, 2015 <a href="http://ocgov.com/gov/ia/reports/jpa\_audited\_financial\_statements">http://ocgov.com/gov/ia/reports/jpa\_audited\_financial\_statements</a>. The following day we sent an email to the Grand Jury informing you that the JPA financial statements were posted on our website.

In May 2016, we posted the new FY 2014-15 audited financial statements for JPAs. Our procedure is to send reminder letters to all JPAs in March and follow up letters if necessary. We will have all financial statements posted by May 31<sup>st</sup>.

For your convenience we have attached a list of all JPAs, and the status of their audited financial statements.
