SUMMARY:

Approve proposed responses to pending recommendations for FY 2004-2005 Grand Jury Reports.

Pending recommendations contain original responses of "requires further analysis" or "will be implemented in the future". Recommendation #9.1

Autonomy for HBP should be explored in light of the needs of the county.

Original Response

The recommendation requires further analysis

Current Status

The recommendation requires further analysis.

HBP is beginning a detailed strategic planning process which will include hiring a consultant to study whether or not it is feasible for HBP to be a separate department. This strategic planning process will be completed within 18 to 24 months.

Recommendation #9.3

Priority should be given to finding appropriate funding for housing the county's archeological and paleontological treasures.

Original Response

The recommendation has not yet been implemented, but will be implemented in the future

Current Status

The recommendation has not yet been implemented, but will be implemented in the future.

RDMD is continuing to work with the cities of Tustin and Irvine on acquiring space at the closed Tustin LTA military base that would be suitable for archeo/paleo artifacts storage.

Recommendation #9.4

A protocol for encouraging, tracking and responding to employee suggestions should be established.

Current Status

RDMD is continuing to work with other internal county partners to develop a protocol for employee suggestions and expects completion by June 1, 2006.

Recommendation #9.5

A provision for continuing HBP input on construction of projects should be established.

RDMD has made improvements in coordination with all internal partners and will have a MOU to formalize these procedures by June 1, 2006.

Recommendation #9.6

Careful analysis of the future costs of deferring maintenance is needed to ensure projects are prioritized properly.

Current Status

HBP is requesting funding in the FY 06/07 budget to hire a consultant to perform an analysis of all facility structures and infrastructure to estimate future repair and replacement costs and create software to track deferred maintenance projects.

Recommendation #9.8

HBP, the OC Board of Supervisors, and employee unions should continue to work together to provide citation authority to park rangers.

Original Response

The recommendation has not yet been implemented, but will be implemented in the future

Current Status

The recommendation has been implemented

Park Rangers were given citation authority as of January 3, 2006.

Recommendation #9.9

All beneficiaries of harbor patrol services, including coastal cities, should contribute to costs. HBP should be consulted about the appropriate level of service to be provided by harbor patrol at HBP expense.

Current Status

The County Executive Office is working with HBP and the Sheriff to find new ways to fund the costs associated with Harbor Patrol.

The county planning department should better coordinate with HBP so RDMD speaks with one voice to ensure easements and dedicated land in new developments meet the county's needs.

HBP should hire an interpretive specialist or establish an alternative way to ensure interpretive programs are appropriate, accurate, cost-effective, and consistent system wide.
