Dear Judge Stock:

I appreciate the time and effort of the Orange County Grand Jury. I have read the report including the findings and recommendations of the report "ICE in Orange County." I am pleased to provide you with my response as requested.

Finding F-3. Cities which contract with OCSD and Costa Mesa have the immigration status of all booked individuals checked. Anaheim has only a part time ICE agent. However, it is unclear if OC's large cities (Santa Ana, Huntington Beach, Irvine, Orange, Fullerton and Garden Grove) check the immigration status of all individuals booked at their city jails.

Response:

Irvine operates a "Temporary Holding Facility" as defined by the California Department of corrections in Title 24, part 2, division viii, Section 470a.1. As such, persons being taken into custody are only in Irvine Police custody for a few hours. As a general rule, all persons arrested for more serious crimes are transferred to the Orange County Jail for housing and release considerations as required by law and the policy of the Orange County Sheriff.

Pursuant to Penal Code Section 843c(a)(1), the Irvine Police booking process does include questions regarding place of birth and place of citizenship. These questions are specifically asked to ensure that consulates of countries listed in Section 843c(d) are notified in the event of the arrest of any foreign national pursuant to this statute.

The Irvine Police Department does not check the immigration status of individuals that are released directly from the Irvine holding facility. Irvine does collect fingerprint data and runs a thorough verification of identity on persons in their custody. In the event that an immigration-related hold was to be discovered, that


person would be transported to the Orange County Jail in relation to the ICE hold for appropriate criminal processing.

Finding R-3. To ensure consistency within OC, the cities of Anaheim, Santa Ana, Huntington Beach, Irvine, Orange, Fullerton and Garden Grove should consider entering into an agreement with ICE, or make an arrangement with OCSD, to ensure that all people booked at their jails have their immigration status checked with ICE and hold UIs for ICE transport to federal facilities. (This recommendation arises from Finding F-3.)

Response:

Persons that are transferred to the Orange County Jail for processing are screened for immigration status in a consistent manner pursuant to the protocol of the Orange County Sheriff.
