Dear Judge Wieben Stock,

This letter is to serve as the required response from the Orange County Sheriff's Department to the Grand Jury Report, "The Anatomy of Safe and Sane Fireworks Sales in Orange County." As specified in the report, I am only addressing Findings F-9 through F-13.

F-9. *Safety officials cannot enforce all laws and municipal ordinances regarding the illegal use of legal fireworks due to the large volume of activity on the Fourth of July.*

Agree, based on current staffing levels.

F-10. *The use of illegal fireworks is significantly greater in cities that allow the sale of legal fireworks.*

Agree, but only as to a comparison of the city of Stanton to other cities serviced by the Orange County Sheriff's Department.

Since we do not patrol the other cities that permit the sale of fireworks, we are not in a position to comment on a comparison of them with other cities.

F-11. *The use of legal fireworks can mask the use of illegal fireworks.*

Agree.

F-12. *Safety officials are of the opinion that legal fireworks sales should be banned in the interest of public safety.*

F-13. *Safety officials can significantly curb the use of illegal fireworks in these cities within three years if the sale of legal fireworks were banned.*

Agree, provided sufficient deputies are deployed to do enforcement work and a public notification program is instituted during that 3 year period.
