The Findings and Recommendations were used to construct the responses to the required Findings that were reviewed by the Ocean View School District Board of Trustees on August 15, 2023, as an informational item, and is respectfully submitted below as requested in the Orange County Grand Jury report and attached cover letter dated May 19, 2023.

Disagree. The Respondent disagrees wholly or partially with the finding	Ocean View School District schools consistently utilize the process of identifying homeless youth. Annually, all schools identify homeless youth during the Re-Registration process and throughout the school year as needed. Ocean View School District is unaware of the protocols used in other Orange County districts.
F4	The majority of McKinney-Vento Liaisons are in full-time positions, but because their work includes multiple non-McKinney-Vento responsibilities, most do not have sufficient time to do the work required by the McKinney-Vento Act.	Disagree. The Respondent disagrees wholly or partially with the finding	Ocean View School District has two Licensed Clinical Social Workers who serve as District Homeless Liaisons. Part of the position as Licensed Clinical Social Workers is to serve as District Homeless Liaisons. Beginning with the 2023-2024 school year, the District will have four Licensed Clinical Social Workers to share the Homeless Liaison responsibilities.
F5	Many McKinney-Vento Liaisons lack needed experience due to a high turnover rate in those positions.	Disagree. The Respondent disagrees wholly or partially with the finding	Ocean View School District Licensed Clinical Social Workers who serve as Homeless Liaisons have been doing so since being hired in OVSD and continue to update skill and knowledge in part through Homeless Liaison training provided by Orange County Department of Education.
F6	McKinney-Vento Act training is not mandatory for the majority of McKinney-Vento Liaisons.	Disagree. The Respondent disagrees wholly or partially with the finding	Ocean View School District Homeless Liaisons participate in regular on-going training with the assistance of the Orange County Department of Education and through the review of District policies and practices.
F7	Students experiencing homelessness who are enrolled in an elementary district often do not continue to receive McKinney-Vento benefits when they move to a high school district because the Federal Educational Rights and Privacy Act (FERPA) prevents the sharing of this information between districts.	Disagree. The Respondent disagrees wholly or partially with the finding	Ocean View School District has a Memorandum of Understanding with the Huntington Beach Union High School District to share student information which parents consent to during the annual Re-Registration process.
F8	McKinney-Vento funds depend on school districts submitting grant proposals, but not all districts have employees trained in writing grant applications, resulting in	Disagree. The Respondent disagrees wholly or	Ocean View School District has staff who write grants to support student achievement and will continue to do so to secure additional funding.

These funds are insufficient to meet the needs of the school districts supporting children experiencing homelessness.	Disagree. The Respondent disagrees wholly or partially with the finding	Due to the support from local agencies and the Orange County Department of Education combined with Title I Part A money, Ocean View School District is able to meet the needs of students experiencing homelessness.
F11	A lack of reliable transportation for children experiencing homelessness often results in chronic tardiness and absenteeism.	Disagree. The Respondent disagrees wholly or partially with the finding	Ocean View School District provides LEA-funded bus passes for students and adults, in conjunction with bus passes provided by the Orange County Department of Education and Orange County Transit Authority (OCTA).
F12	Chronic Absenteeism Rates of Homeless Students are disproportionately high in comparison with the Chronic Absenteeism Rates of All Students and Socio-Disadvantaged Students.	Disagree. The Respondent disagrees wholly or partially with the finding	Ocean View School District, like most school districts, has experienced higher rates of Chronic Absenteeism as a result of the COVID-19 pandemic. Since the pandemic, students experiencing homelessness do not have a disproportionately higher rate than other student groups.
F13	Children experiencing homelessness in Orange County perform at a lower level on standardized tests and have a lower graduation rate than All Students and Socioeconomically Disadvantaged Students.	Disagree. The Respondent disagrees wholly or partially with the finding	Ocean View School District serves a small percentage of students in grades TK-8 who live in Orange County and do not have access to student information in other districts nor does Ocean View School District have access to achievement results or graduation rates for students who matriculate into high school. Students experiencing homelessness are not achieving at a lower level on

			standardized tests than other student groups.
F14	The percent of Homeless Students graduating who failed to meet state standards on English Language Arts and Math tests is significantly higher than it is for All Students and Socioeconomically Disadvantaged Students.	Disagree. The Respondent disagrees wholly or partially with the finding	Ocean View School District serves students in grades TK-8 and does not have access to achievement results for students who matriculate into high school.
F15	There is a tendency by school districts to operate in isolation, which prevents productive collaboration on addressing the issue of children experiencing homelessness and the challenges of their education.	Disagree. The Respondent disagrees wholly or partially with the finding	Ocean View School District works collaboratively with the Orange County Department of Education and community agencies such as the Family Resource Center to support students and families experiencing homelessness.
F16	A significant lack of affordable permanent housing contributes to many families being caught in the cycle of homelessness.	Disagree. The Respondent disagrees wholly or partially with the finding	Families experiencing homelessness have voluntarily shared a variety of reasons for homelessness such as mental health, addiction, job loss, and economic reasons. The role of the District Homeless Liaison is to identify the support students experiencing homelessness need to remain in school. It is not their role to determine the cause of the family situation.
