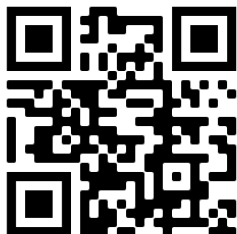

The role of a Grand Jury differs substantially from a trial jury. It is a fulltime assignment. Approximately 80% of time is spent in a civil watchdog role with remaining time spent in criminal indictment hearings. No jury trials and all proceedings are closed to the public.

Judges of the Grand Jury Recruitment and Selection Committee review applications and select no more than 90 applicants, proportionately distributed from the five O.C. Supervisorial Districts.

02/23/2024

Jury Commissioner confirms selected candidates and informs all applicants by mail.

02/28-3/22/2024

O.C. Sheriff's Department conducts no more than 90 background investigations.

04/02-12/2024

Grand Jury Recruitment and Selection Committee members conduct interviews.

04/1/2024

Grand Jury Recruitment and Selection Committee votes to confirm slate of 25-30 candidates to proportionately represent the five O.C. Supervisorial Districts.

04/22-30/2024

Superior Court judges vote to approve the final slate of 25-30 Grand Jury nominees (majority approval required).

05/2/2024

Names of the 25-30 candidates to be published and all candidates notified by mail.

05/08-17/2024
