Please accept this letter as the City of La Habra's timely response to the 2023-2024 Orange County report entitled, "Law Enforcement's Response to Mental Health Calls for Service," which was received by the City of La Habra on June 3, 2024. On August 19, 2024, the City Council of the City of La Habra reviewed the above-referenced Grand Jury Report and authorized the delivery of this letter as the City's response to the Grand Jury's findings and recommendations pursuant to California Penal Code Section 933. Each of the findings and recommendations is listed below in italics, followed by the City's response.

FINDINGS:

F1. Mental health training for law enforcement officers in Orange County exceeds the State's requirements, resulting in law enforcement applying these skills to better evaluate and handle mental health calls for service.

Response: This City AGREES with this finding.

Explanation: The City of La Habra concurs with the concern of the Grand Jury and makes every effort to train its officers and supervisors to respond safely and appropriately to calls related to mental health. The City and Police Department understand the importance of collaboration with outside resources such as Be-Well OC, PERT and the Hope Center. The City and Police Department recognizes that even given the exceptional service in this case, finding new or improved ways to respond to mental health calls for service should always remain a priority.
